Conditions for participation in the Flathead Lake Festival of Art as a food vendor:

1. A license with the State of Montana is required (please attach a copy with application). For more information, contact the Lake County Environmental Health Service.
2. All food vendors must meet the Lake County Regulations for sanitation. Vendors are responsible for the clean-up of their individual spaces during and after the show.
3. All food vendors are required to have a separate permit through the City of Polson. Contact City of Polson, Parks & Recreation at 406-883-8200.
4. Limited electricity may be available, however, food vendors need to be prepared to provide their own power source.
5. Booths will be set up on time and will remain open the entire duration of the show.
6. The show is outdoors and lakeside. Be prepared for rain or wind; the show will be held regardless of the weather. Security will be provided Friday and Saturday night, however, each vendor participates at his or her own risk. The Sandpiper Art Gallery and show staff are not responsible for damage, theft, or loss of any vendor's product or property.

I agree to the above requirements and have attached a copy of my license. I assume all responsibility for my products and for safeguarding my booth/food trailer. I hereby release and hold harmless Sandpiper Art Gallery and its agents for any damage, loss or injury resulting from my participation in this event. I certify that I have valid Liability Insurance and am responsible for any damage caused by myself, my products or my booth/food trailer.
